MSPO SUPPLY CHAIN CERTIFICATION STANDARD

The Malaysian Sustainable Palm Oil-Supply Chain Certification Standards (MSPO-SCCS) covers management requirements and traceability of palm oil production throughout its supply chain - from raw materials to processing to manufacturing of palm oil and palm oil-based products. The MSPO-SCCS aims to deliver confidence and credibility to customers and end users that the palm oil raw material originates from sustainably-managed oil palm planted areas.

This MSPO-SCCS examines the roles and responsibilities of the parties in enabling the traceability of all activities throughout the palm oil supply chain. It discusses requirements for a Supply Chain Management System, including a Sustainability Policy, management representative, record-keeping, operating procedures, internal audits and management reviews. It also looks at resource management, traceability, as well as claims, complaints and grievances.

Implementation of the MSPO-SCCS is mandatory for all palm oil processing facilities, as part of the Malaysian government's commitment to ensure production of certified sustainable palm oil.

MSPO Standards contribute to the UN's Sustainable Development Goals (SDGs), specifically:

Goal 12: Responsible Consumption & Production

Goal 13: Climate Change

Goal 15: Life on Land
